



The Indian Removal Act	abolish	to officially end something, such as a law or practice
Indigenous People of the Southeast	assimilate	to adopt the language, beliefs, and customs of a dominant culture, often reducing or replacing one's original culture
The Second National Bank Crisis	Bank War	the political conflict in the 1830s over whether the United States should keep the Second National Bank
The Rise of Jackson	cabinet	a group of advisors chosen by the president to help make decisions and run the government
The 1824 and 1828 Presidential Elections	campaign	organized actions people take to win an election
The 1824 and 1828 Presidential Elections	candidate	a person running for an elected position
Trail of Tears	cede	the act of giving up land or territory to another country or group through a treaty or agreement
The Second National Bank Crisis	dividends	payments made to stockholders from a company's profits
The 1824 and 1828 Presidential Elections	corrupt	dishonest or willing to act unfairly for personal gain
The 1824 and 1828 Presidential Elections	corruption	dishonest or illegal actions by people in power for personal gain
The Second National Bank Crisis	credit	the ability to borrow money with a promise to pay it back later
The 1824 and 1828 Presidential Elections	Democratic-Republicans	a political party in the early United States that supported states' rights and farming interests
The Indian Removal Act	dependent	a person or group that relies on another for support, such as food, shelter, or care
The Indian Removal Act	Doctrine of Discovery	a belief used by European countries to claim land by saying they had the right to take land not ruled by Christians

The Indian Removal Act	Indian Removal Act of 1830	a law passed by the U.S. government that forced many Indigenous Nations to move west of the Mississippi River
The 1824 and 1828 Presidential Elections	Jacksonian democracy	a political movement in the 1800s that expanded voting rights for most white men, strengthened the power of the president, and encouraged greater public participation in government
The 1824 and 1828 Presidential Elections	mudslinging	the use of insults or accusations to damage an opponent's reputation in politics
The Second National Bank Crisis	negate	to cancel out or make something have no effect
States' Rights and the Nullification Crisis	nullification	the idea that a state can cancel a federal law it believes is unfair
States' Rights and the Nullification Crisis	nullify	to cancel or make something have no effect
Political Participation in the Age of Jackson	participatory democracy	a system where people are directly involved in making decisions about government and politics
The 1824 and 1828 Presidential Elections	platform	a set of ideas and goals that a political party or candidate supports
The 1824 and 1828 Presidential Elections	populist	a leader or movement that claims to represent the common people against elites
The Second National Bank Crisis	riot	a violent disturbance by a crowd of people, often in protest or anger
States' Rights and the Nullification Crisis	scede	to formally leave a group, country, or union
States' Rights and the Nullification Crisis	secession	the act of breaking away from a group, country, or union
The Second National Bank Crisis	Second National Bank	a government-chartered bank created in 1816 to help manage the nation's money and debts



The Rise of Jackson	Second Party System	the period in US history when the Democrats and Whigs were the two main political parties
The Rise of Jackson	spoils system	the practice of giving government jobs to political supporters as a reward
The Second National Bank Crisis	stockholders	people who own shares of a company and may earn profits from it
Political Participation in the Age of Jackson	suffrage	the right to vote in political elections
States' Rights and the Nullification Crisis	tariff	a tax placed on goods brought into a country
The Rise of Jackson	The Whigs	a political party in the 1800s that opposed Andrew Jackson and the Democrats
Trail of Tears	Trail of Tears	the forced journey of Native nations from their homelands to lands west of the Mississippi River where thousands died from hunger, disease and hardship
States' Rights and the Nullification Crisis	Treason	the crime of betraying your country or helping its enemies
